Series 4. Publications and Promotional Material: Arranged by subject, then chronologically within each subject.

Series 5. Miscellaneous: Arranged by subject, then chronologically within each subject.

Series 6. Photographs: Arranged chronologically.

Series 7. Oversized: Since the records of this series are small in number, they are in no particular order.

Scope and Contents of the Materials

This collection of records contains material that documents both the administrative and public activities of Southeastern Minnesota Visual Artists (SEMVA) from 1989 to 2015. Meeting minutes, newspaper clippings, and newsletters are especially well represented. Photographs further document SEMVA activities. The bulk of the material is from the 1990s.

Series 1. Activities

This series contains material related to public activities either hosted by SEMVA or attended by SEMVA members, including classes, exhibits, and events. A handful of items date to the 2000s and 2010s, but most of the items date from the mid-1990s.

Series 2. Administrative Files

This series contains material related to the administrative activities of SEMVA. Documents include by-laws, correspondence, legal records, financial material, meeting minutes, organizational structure, and membership. Most of the items date from the early to mid-1990s. Meeting minutes make up the bulk of this series and are comprehensive from 1989 to 2005.

Series 3. Newspaper Clippings

This series contains newspaper and magazine clippings related to SEMVA activities and artists and art in Rochester. Some of the clippings are simply ads for SEMVA that appeared in various publications. The clippings are comprehensive from 1989 to 1998, with heavy concentration in 1992 and 1993. From 2003 onward, clippings are limited.

Series 4. Publications and Promotional Material

This series contains SEMVA publications and material related to promoting the organization. Items include brochures, press releases, and documents regarding promotional agencies and opportunities. Newsletters make up the bulk of this series and are comprehensive from 1990-2008. Most of the other items date from the early to mid-1990s.

Series 5. Miscellaneous

This series contains a variety of material related to SEMVA, most notably certificates and gallery logs.

Series 6. Photographs

This series contains photographs documenting numerous exhibits and events in which SEMVA and its members participated. Most of the photographs date from the 1990s.

Series 7. Oversized

This series contains a limited number of items that are too large to fit elsewhere in the collection, including a photograph and artwork.

Biographical Note

Southeastern Minnesota Visual Artists, an artists' cooperative, formed in Rochester, Minnesota, in 1988 with the mission of assisting and promoting artists from southeastern Minnesota. For the first few years, members met socially as a group and organized art shows to display members' work. SEMVA incorporated in 1991 and in 1992 opened a gallery in a downtown Rochester store fronting on the Peace Plaza. Aside from the gallery, SEMVA and its members displayed art at other locations around Rochester. The gallery at this location existed and thrived for 23 years. All artists took turns working as clerks in the gallery, and members who had special skills in accounting, marketing, maintenance, and administration performed those tasks as unpaid volunteers. In late December 2015, the gallery was forced to close when lease negotiations with the landlord broke down. At that time, there were more than 80 exhibiting members of SEMVA. In February of 2017, SEMVA obtained a new gallery space at 320 South Broadway.
